### **MAA Environmental Policy Statement**

As a part of the University of Cambridge, the Museum of Archaeology and Anthropology (MAA) implements the University Environmental Policy and Strategy and seeks guidance from the Environmental Office and other resources as appropriate. As a member of the University of Cambridge Museums (UCM) consortium, MAA also implements the additional commitments of the UCM Environmental Policy. These policies are set out below:

### **University of Cambridge Environmental Statement**

In achieving excellence in teaching and research, the University of Cambridge aims to manage its activities, buildings and estates to promote environmental sustainability, to conserve and enhance natural resources and to prevent environmental pollution to bring about a continual improvement in its environmental performance.

#### **Our commitments**

The University will comply fully with environmental legislation and officially approved codes of practice, and will make continued efforts to reduce its environmental impact through the implementation of an Environmental Plan which sets out a range of objectives and targets related to its significant environmental impacts, including:

- to promote sound environmental management policies and practices in the work of all Faculties, Departments, and other institutions;
- to increase awareness of environmental responsibilities amongst staff and students;
- to work with other agencies locally, nationally, and internationally to promote appropriate environmental policies;
- to implement policies and procedures that contribute to a reduction in the University's carbon footprint;
- to minimise waste and pollution, and to operate effective waste management procedures;
- to reduce the consumption of fossil fuels;
- to reduce water consumption;
- to promote a purchasing policy which will give preference, as far as
  practicable, to those products and services which cause the least harm to the
  environment;
- to avoid use, wherever possible, of environmentally damaging substances, materials, and processes;
- to maintain the grounds and buildings of the University estate in an environmentally sensitive way;
- to have regard to environmental factors as far as practicable in respect of the growth of the University and the integration of new developments into the local environment;
- to encourage modes of transport by staff and students which minimise the environmental impact;
- to communicate with interested parties on issues relating to the Environmental Policy including contacts in the immediate neighbourhood, and the regional, national and global community.

The University of Cambridge has an environmental action plan as a whole, and an Environment and Energy Section, part of Estate Management, deals with waste management, procurement, the built environment, biodiversity, travel, and environmental management in general. An environmental management system (EMS) based on ISO 14001 has been implemented to help strengthen the management of environmental issues throughout the University. The EMS is externally certified under the EcoCampus scheme and achieved the Silver Award level on 24 February 2011. There is an Environmental Strategy Committee that oversees environmental issues and the Environmental Plan, while representatives of the Environmental and Energy Coordinator network distribute the monthly sustainability newsletter, *Greenlines*, keeping University stakeholders informed.

The Electricity Incentivisation Scheme is run each year to reduce the amount of electricity used across the University Estate. A water conservation programme is maintained to hold water consumption at 2009/10 levels based on .5m3 per m2 of University Estate.

The whole University community is encouraged to take part in green initiatives through the 'Cambridge Green Challenge' identity. As part of this the University runs an annual Switch Off Week each year from 2013, working with staff, students and visitors to encourage efficiency and reducing waste through switching off unnecessary electrical equipment.

#### **UCM** specific policies

UCM have adopted the University Museum Group Declaration of 10 December 2010<sup>1</sup>, which builds on the National Museum Directors' Council guiding principles for reducing museums' carbon footprint<sup>2</sup> which was accepted by the European Bizot Group of major museums in May 2009.<sup>3</sup>
